**ALL DOGS MUST** be on leash or kenneled unless showing in the ring.

DES MOINES OBEDIENCE TRAINING CLUB (DMOTC) may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other cause, and no one shall have any claim or recourse against DMOTC or any official thereof.

### Attention Rally Exhibitors:

**Rally Classes will be run small to tall. The trials will be run concurrently (Master 1, Master 2, Excellent A & B 2, Excellent A & B 1, Advanced A & B 1, Advanced A & B 2, Intermediate 2, Intermediate 1, Novice A & B 1, Novice A & B 2.) No transfers day of trial will be allowed in Rally.**

### Attention Exhibitors

Friday, Saturday & Sunday the show site will be available to exhibitors one hour before the start of judging. The building will be closed and dogs must be removed from the show site each trial within 30 minutes of the completion of judging.

Please leave the motel and motel grounds clean. Any complaints from proprietors will be handled by the Show Committee.

Telephone, email and unsigned entries cannot be accepted. Entries not on an Official AKC Entry Form and photocopies of entry forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

Make all checks and money orders payable to Des Moines Obedience Training Club. Canadian exhibitors must make fees payable in US funds. Payment must accompany entries.

Mail all entries to Deb Owens, 508 2nd Ave, Luther, IA 50152. Entries received without fees will not be accepted. Acknowledgement of entries will be made as soon as practical. Unless an exhibitor specifically requests postal communication, submission of an email address on the entry form will serve as authorization to send communication, including entry confirmation via email. It is the exhibitor's responsibility to ensure that their email software will accept messages from dmotcobsecretary@gmail.com

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of Show Committee or AKC. The well-being of dogs, exhibitors and spectators is of paramount importance, and in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

**DMOTC does not agree to arbitrate claims as set forth on the Official AKC Entry Form for these events.**

Owners are responsible for errors on completed entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Post-dated and returned checks do not constitute a valid entry. A collection fee will be added to the amount of each returned check.

No refund for duplicate entries. Care will be taken to find duplicates, however, if an entry has been processed, no refund will be made.

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee be asked to leave the trial site. There will be no refunds of entry fees if a person is asked to leave the trial site.

Dogs may not arrive prior to 30 minutes before their scheduled judging. Dogs not required for further judging may be excused. Judges will not wait for any dog holding up a class. Owners or agents are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

Class prizes will be distributed in the ring to the person showing the dog. Claims must be made in the ring before the judging for that show is over, and the Secretary advised at once. All prizes must be claimed at the show. If not, they become the property of DMOTC. No prizes will be mailed.

DMOTC, the show secretary, members of the show committee, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by spectators, exhibitors, handlers, their employees or children, etc. or to any of their dogs or property. Entrants and spectators to this show do so entirely at their own risk.

This show is governed by The American Kennel Club. Exhibitors should read the AKC agreement on the entry blank in the premium list.

Des Moines Obedience Training Club policy allows the Obedience/Rally trial secretary to enter these events.

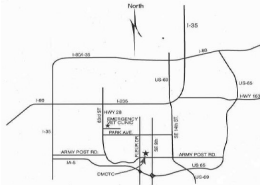

### **Covid-19 Social Distancing Plan**

Iowa Governor Kim Reynolds Disaster and Emergency Proclamation was updated May 27, 2020. The proclamation requires social distancing measures for public or private gatherings outside the home that include a site distance plan requiring at least 6 feet between individuals, and it must be maintained at all times. This plan is designed specifically for the DMOTC All Breed Obedience Trials to be held at the DMOTC building located at 1423 Army Post Rd in Des Moines, Iowa on NOVEMBER 20, 21, & 22, 2020.

**Any person who fails to follow this plan and maintain at least six feet between individuals at all times during this event or on the show grounds during show hours will be investigated by the trial committee for misconduct prejudicial to the interests of the sport and may result in expulsion from this event and possible sanction by AKC.**

1. **If you feel unwell**, have a fever, cough or are sneezing before leaving for the trial, please stay home. If you have recently been in the presence of a person who has either tested positive for COVID-19 or has the symptoms noted above, stay home. You can text the event secretary (515-230-4989) if you are unable to attend.
2. **These trials will be held under the:**  
[AKC Obedience & Rally Suggested Best Practices for the Well-Being of Dog-Sport Participants](#) as of May 12, 2020.  
**Gloves, articles and dumbbells will be handled by tongs or grabbers which will be disinfected between dogs. All leashes will be handled and placed only by the exhibitors except in Novice when the leash will be handled by tongs or placed on a clipboard or the handler may be asked to place the leash on a rack or chair in the ring after the stand for exam and before off lead heeling.**
3. **Trial—single trial per day** There will be 2 Concurrent Rally Trials on Friday, 1 obedience trial on Saturday and 1 obedience trial on Sunday. The building will have 1 ring set up and there is 1 judge per trial all days. To minimize the number of persons in the building or on the grounds, no more than 10 exhibitors will be allowed in the building at a time and only during their class. Only ONE class at a time will be allowed in the building. The Gate Steward will provide information on who is allowed to enter the building. The exhibitors will have time to set up and prepare to show before being called into the ring. Only exhibitors for that class may be allowed in the building and must be spaced at least six feet apart at all times. Exhibitors will need to leave the building after their class.
4. **Start Times— The 1st class will start at 8:00 AM each day.** Please time your arrival to the show grounds for check in NO MORE than 30 minutes before your scheduled start time. **There will be a scheduled start time for each class.** Upon completion of your class and awards, please leave the grounds so others may use your parking space.
5. **The DMOTC obedience committee is providing:**
  - A. A text messaging system to update the obedience class run times and order—more information will be provided in your Exhibitors' letter .
6. **There will be NO** indoor crating except when your class is in building. Exhibitors wait in vehicles to be called. If you bring a crate in, please remove it quickly at the conclusion of your class. At the conclusion of your class the exhibitors of that class will be allowed to enter the building to remove crates and chairs prior to the entrance of the next class.
7. **Tents:** a limited number of pop up tents can be placed in the grassy area behind parking on a 1st come basis. Dog exercise areas will be marked at the East and West of the grassy area and a tent must be at least 10 feet from the dog exercise areas. A map will be provided in your Exhibitors' letter. NO tents may be left overnight and all tents used are the owner's liability due to security concerns.
8. **Parking** Please be aware and maintain the 6-foot spacing from other exhibitors and spectators at all times. If possible, leave 1 parking space between each vehicle.
9. **Dog Exercise Area** Dogs must be maintained on a leash no more than 6 feet in length. Pick up after your dog and dispose in a can in the exercise area, or pack it out with you. Give space to those exhibitors preparing to enter the building to compete.
10. **Hand Washing** There will be hand sanitizer stations as you enter the building and hand washing in the restrooms. Please use at least once per hour when in the vicinity of the building and after using the restroom.
11. **Door handles and common surfaces** will be wiped down at lunch break and after closing Saturday and Sunday.
12. **Check In** - there will be a self-check in table as you enter the building just past the entrance door (not the glass double doors) . Do not check in until you receive a text message to do so. Stay behind the taped line to maintain six-foot distance until it's your turn. **Bring your own pen to mark yourself present** and pick up the info packet containing armband numbers, & rubber bands. **Please print your own Judging Program from your Exhibitor's letter and information packet.** None will be provided at the trial.
13. **Class Staging**
  - A. Wait in your vehicle until your class is called. Please leave grounds promptly at the completion of your class. You can sit in your vehicle with windows down and talk to those on either side of you . Or set up chairs by your vehicle to chat, but keep at least SIX FEET apart.

- B. **Gate Steward** will announce your class.
  - C. **When your class is called**, enter the building from the NORTH door, marked ENTRANCE for the show, without your dog to set up your chair and crate if needed, in a designated space. Exit through the SOUTH door with the wood railing, marked EXIT for the show. Return with your dog to set-up.
  - D. **Face Masks/Face Coverings** Every person in the building must wear a face mask/covering except when in the ring. Keep mask on outside if likely to come within six feet of any other person. Mask use by ring and table stewards will be at the discretion of the stewards. All stewards will maintain at least 6 feet or greater distance from exhibitors at all times. The judge may be wearing a face mask/covering but will maintain social distance.
  - E. **Chairs** please bring your own chair into the building to minimize the need to sanitize chairs between classes.
  - F. **Walk Through** Line up for walk through if offered for your class, no more than 5 exhibitors will be allowed per walk through. If there are more than 5 exhibitors in the class there will be multiple walk throughs per class. When walking the course there must always be at least one station sign between you and the person before you.
  - G. **Exit building promptly** after judging. We suggest you take your dog out first and then you will be allowed to re turn for your chair and crate at the end of your class prior to the entrance of the next class. If you are done for the day, please head home so that other can take your parking place.
  - H. **Ring steward** will call each dog ringside in catalog order for the class. Be sure to remain at least six feet from the stewards' table, the ring entry, and the dog leaving. After competing, remove your dog from the ring and exit the building.
  - I. **Maintain** at least six feet between you and other exhibitors at all times.
13. **Judges and stewards** will maintain social distance as practical in and around the ring between each other, exhibitors and spectators. Hand sanitizer or washing supplies will be near the ring entry along with Kleenex and a bag for disposing of same.
14. **Awards** At the conclusion of each class, the judge will call qualifiers to the ringside.
- A. Maintain a minimum of six feet between each exhibitor. Your dog need not be present for this ceremony.
  - B. Steward will sanitize hands (or put on gloves) before sorting ribbons.
  - C. Steward will place the ribbons on a table and exhibitor will pick up on their way out of building.

17. **Food on premises** There will be no vendors or food available on site. Club will not provide snacks or water to exhibitors, so please pack your own and pack your empties out. There are fast food restaurants close by if you need to purchase lunch while in the area.
18. **Lunch** will be on your own for all exhibitors. Judges, stewards and committee members will be served commercially packaged box lunches to eat in their vehicles or other socially distanced areas.
19. **Contact Tracing** If you become ill with Covid-19 after this event, please let the Trial Chair know. We will ask others in a class with you to seek medical advice on distancing due to possible exposure. We will NOT share your identity in doing so. If you are contacted by a Public Health tracer, you can refer them to the Event Secretary to get the names and contact information of others you may have been in contact with at this event.
